The appellant sought the following information through online RTI application dated 02.06.2019 about the Recruitment of Scientific Assistant in Indian Meteorological Deptt.

1. How many candidate have finally joined till now.
2. How many appointment letter IMD have sent to candidates till now against 1102 vacancies.
3. How many candidates are on extension for final joining till now.
4. What is maximum limit (in days ) to take extension for final joining.
5. How many months waiting list is valid.


CPIO provided the information to the appellant as received from the concerned section (E-II) of this office through online on RTI\_MIS Portal dated 17.06.2019.

1. More than 800.
2. 975.
3. More than 90.
4. Kindly refer DoPT O.M. No.1259494-Estt(D) dated 09.08.2017 in this regard.
5. Kindly refer DoPT O.M. No. 41019/18/97-Estt.(B) dated 13<sup>th</sup> June 2000.

Aggrieved from the aforementioned reply of CPIO the appellant preferred the appeal on 08.07.2019 wherein he reiterated to provide the information at S. No. 1 & 3 in his RTI request. Appellant wants to know the actual number of candidates instead of round figures.

DECISION



It is directed to the concerned Section(E-II) to provide the exact number of candidates as on date to the appellant regarding S.
