All quarters of IMD are Duty Post Quarters meant for officers/staff for performing operational duties/essential duties and allotment of these quarters is being done as per the rules framed by IMD through AAC (Allotment Advisory Committee) of IMD. However, the competent authority (Director General of Meteorology) may for any reasons to be recorded in writing relax any or all other provisions of these rules in the case of any allottee or any accommodation or any group or class of allottee or type of accommodation or on any other matter, based on operational priorities and individual associated. One number of quarter has been allotted since last two year on medical ground in New Delhi under the discretionary power of the competent Authority. However no quarter has been allotted as per Directorate of Estate OM No. 12035/2/97-pol. Ii(pt.11) dated 17.11.1997.(Prescribed rules for allotment of IMD Residential quarters are sent through e-mail address- prashantraj9161@gmail.com)

2. No Type II and Type III quarters are vacant in Observatory Compound New Delhi..
