In the event of the tender opening date being declared as holiday, the tender will be opened on the next working day; the venue and time of tender opening will remain the same.

Service contract will be awarded on following terms and conditions:

- 1. The Annual Maintenance Contract is for the period of two years from the date of issued as per approval by competent authority.
- 2. The service provider shall be based in Delhi NCR.
- 3. The service provider shall provide direct service and shall not employ Sub- Contractors for execution.
- 4. There shall be two types of Maintenance Service to be carried out by the Service Provider viz. Preventive Maintenance Service(PMS) and Breakdown Service(BDS).

Preventive Maintenance Service (PMS):

Every machine shall be serviced at least once every month. A record of such service, duly acknowledged by the person in charge of the location of the Air- Conditioner, shall be maintained, and produced along with bill.

Breakdown Service (BDS):

Breakdown calls shall be attended to immediately/swiftly and a record of such service, duly acknowledged by the person in charge of the location of the Air- Conditioner, shall be maintained and produced along with bill for office records.

- 5. This Annual Maintenance Contract shall be Comprehensive contract for different types of Air- conditioners and for different types of maintenance. Comprehensive service includes replacement of all spares except front panel, plastic components, electrical installations, brazing works etc.
- 6. There shall be a minimum of two teams stationed at out premises on full-time basis, each team consisting of 1 technician and 1 helper, at any given point of time. The number of teams shall be suitably increased by the service provider, if necessary, in order to provide a satisfactory service.
- 7. There shall be an exclusive person posted at our premises on a full-time basis to receive the complaints, over phone and in person. The contact details may be provided on receiving work/supply order.
- 8. All the technicians and helpers posted on duty shall sign the attendance prescribed for the purpose. Any absence/default in this regard would involve proportionate deduction of AMC charges payable in the service provider.
- 9. Repeated absence/default in this regard shall lead to termination of contract.
- 10. All break-down calls shall be attended to immediately and in any case, the same day. Breakdown calls that could not be attended to on the same day for exceptional reasons shall be attended to the next day without fail.
- 11. The firm should provide standby Air Conditioners, if any unserviceable Air Conditioners is required to be taken from the office to the firm's workshop or elsewhere for repair/replacement of spare part in case of major breakdown in an AC, if the AC is taken to the firm's workshop, the firm will bear the charges like; transportation, loading/unloading, repair/service, cost of the parts replaced, etc.

- 12. Units taken out of the office premises for service at the workshop shall be returned at the earliest and in any case, within a week's time. Non- attendance of complaints of this nature beyond a week would entail deduction of penalty of Rs. 200/- per day. Unit till the complaint is attended to.
- 13. Quarterly bills shall be submitted to the undersigned along with the Service Report acknowledgements from controlling officials (both for Preventive Maintenance Service and for Break-down Maintenance Service) before 5th of the following month.
- 14. Payment shall be made after verification of the Records and the same shall be restricted to actual number of Air-Conditioners serviced during the month.
- 15. The payment for the final month shall be made to the selected Service provider only after completion of handing over of all Air-conditioner Units in working condition to the successor service provider land after receipt of take-over note from the successor-service provider.
- 16. DGM (HQ) reserves the right to terminate the contract at any moment in the case of unsatisfactory service and contract will have no claim for the work and period of unsatisfactory service rendered.
- 17. In case of dispute, the decision of DGM (HQ), New Delhi will be final and binding to all.
- 18. On the expiry of AMC the firm should surrender all the Air Conditioners in working condition.
- 19. Initially AMC will be given for two years; however same can be extended on successful & satisfactory completion of the contractor on same terms and conditions.
- 20. The approx nos. of Window, Split and Tower ACs are 98, 46 and 06 respectively. Nos. of different types of ACs may be increased or decreased during the contract period as per the requirement of the office.
